Fees – The host organization agrees to pay the Klein Soccer Club (KSC) the total fee listed below in advance of the tournament. A deposit of 20% of the total fee is due when this form is turned in, and the balance must be paid in full at least two weeks before the tournament.

Refunds and Cancellation – FIELD USE FEES ARE NON-REFUNDABLE IF THE EVENT IS CANCELED BY THE HOST OR BY KSC DUE TO WEATHER. FIELD CLOSURE DECISIONS LIE SOLELY WITH THE KSC BOARD OF DIRECTORS OR ITS DESIGNATED REPRESENTATIVES.

Referees- KSC’s Vice President-Referees or designated USSF assignor(s) will be the sole assignor of officials in any KSC board approved tournament at Meyer Park. This includes any so called showcase, friendly, minor or major tournament and any other soccer organizations use of Meyer Park as an overflow for their tournament. All approved assignors will be a registered and insured through USSF. A referee must be currently certified with USSF and have a current STYSA “KidSafe” document. Non U.S. resident referees must have a letter of introduction from their countries Referee Association, proof of insurance and valid United States Visa and or work permit. Referees under the age of 16 must have parental permission. Failure to adhere to these requirements could result in Klein Soccer Club’s voiding of this tournament field use agreement and forfeiture of any deposits. **EXCEPTION:** Friendly, exhibition or competitive College or Junior College Games must use NISOA registered referees that have all the requirements as USSF officials.

Concessions – The concession stand at Meyer Park can be opened upon request but only under the standing contract of the KSC. Any rebates due under that contract are payable to KSC. If any other items are to be sold at the event (including admission charges or other fund raising), such sales are subject to the approval of KSC and Harris County. This approval process can take 30-45 days.

Security- For tournament play, the host organization must have adequate personnel on site to assist in traffic flow and other security issues, including preventing the distribution of advertising fliers at the park.

Trash – Trash receptacles are placed throughout the park. It is the host organizations responsibility to see that all trash be placed in a receptacle. Harris County personnel will empty the receptacles.

Insurance – Meyer Park fields are intended for use in USYSA sanctioned soccer activities. If the tournament is not sanctioned by USYSA, please provide proof of adequate insurance with this request.

Accounting – Harris County requires that KSC provide a simple accounting of all special events held at Meyer Park. For tournament play, the host organization is required to provide KSC, within 60 days of completion of the tournament, a statement showing the source and amount of revenues, expenses, and payees.

Approval Process – Submit this completed form by hand delivery or mail (PO Box 11973, Spring, TX 77391) to the KSC office with the deposit. Direct your request to the KSC Vice President-External Affairs to present to the KSC Board of Directors at their meeting on the Monday following the first Wednesday of each month. Tournament field use requests will be acted upon only at regular Board meetings. Failure to comply with the terms and conditions of any tournament approval will affect future tournament requests. Tournament requests will not be approved if it conflicts with scheduled KSC activities or with field maintenance periods (usually from May through Labor Day and from mid-December through the end of January).
